

Vistra Employee State PAC is a state-only PAC financially supported by all non-exempt employees who are U.S. citizens or in the U.S. on a permanent-resident visa and exempt employees and who supervise bargaining unit employees for at least 50% of time on job and are U.S. citizens or in the U.S. on a permanent-resident visa. Vistra Employee State PAC gives to Texas state candidates.
